## REGULATIONS FOR ART IN RESIDENCE AT RICKLUNDGÅRDEN

**For artists who are looking for a residency at the Skrivarstugan (writer's cabin), it is suitable for smaller works that does not require durable or robust surfaces. We recommend that you intend to work with, for example, writing, poetry, drawing, research, embroidery, music making or something else.**

§ 1. The board appoints the artist who has applied for a work stay at Ricklundgården. In this context an artist also means other performers than visual artist.

§ 2. The following space is available for art in residence at Ricklundgården:

**Skrivarstugan:** Studio (17 m<sup>2</sup>) with convertible sofa, sleeping alcove with a bunk bed, a small kitchen and toilet with shower. Own washing machine. Wifi is available.

**Cleaning of occupied spaces is provided by the artist. If the cleaning is not carried out according to instructions, the tenant is charged an extra 2500 SEK. Cleaning can be purchased for 2000 SEK. Cleaning can only be booked upon confirmation made by e-mail.**

**The artist can bring their own bed linen and towels, or rent at cost of 150 SEK /stay.**

§ 3. The period of stay in the Skrivarstugan is 10 days.

- In Skrivarstugan, the stay starts on the 1st Friday of the month and lasts until the 2nd Sunday of the month.

**Searchable months are:** February, March, May, September, October and November.

§ 4. Art in residence in the **Skrivarstugan**, the artist pays a rent of SEK 3,000 for 10 days.

NOTE: If there are two artists who are looking for accommodation together in the same studio the cost is 3000 SEK per person. **The price is per person.**

**For each additional person 300 SEK is added per night.**

**Kids under 16 years: free**

*In specific cases, an additional person may be granted a stay at no additional cost if this is considered necessary by the board in order for the artist to be able to carry out his work, eg. personal care giver.*

Included in the art in residence price: bicycles, kick-sled, possibility to light a fire and spend the night in our goahti, own jetty (swimming is possible) and fire pit by the lake. Ricklundgården also has a boat that can be borrowed by agreement. In addition, we have full garbage disposal in the yard. Broadband/Wifi is included. Renting an outdoor electric outlet for an engine heater costs

SEK 100 / week. Grocery store is within walking distance. Fishing licenses are available for purchase at Fiskecentrum.

§ 5. Payment is made via invoice that is sent to your email on arrival (unless otherwise agreed) with a payment period of 30 days.

§ 6. Smoking is prohibited both indoors and in the garden.

§ 7. All who has gained an art in residence at Ricklundgården does not have the right to make changes in the house fixed or loose inventory or otherwise change the nature of Ricklundgården. If something breaks, the tenant becomes liable for compensation.

§ 8. For reasons of allergy, fur animals are not allowed at Ricklundgården.

§ 9. Cancellation for granted art in residence must be notified to the foundation via e-mail to: [info.ricklundgarden@gmail.com](mailto:info.ricklundgarden@gmail.com) as soon as possible.

The artist is **obliged to pay a cancellation fee, which is half of the rental fee** for the stay, if the cancellation is made later than 3 month before the start of the stay.

The artist is **obliged to pay a cancellation fee, which is the whole rental fee** for the stay, if the cancellation is made later than 1 month before the start of the stay.

*We need these guidelines as our residence is outside areas with continuous local traffic / transportation that makes it possible to quickly arrive or travel from Saxnäs. It is highly improbable to find a replacement within 1 month who can fill a vacancy at such short notice.*
